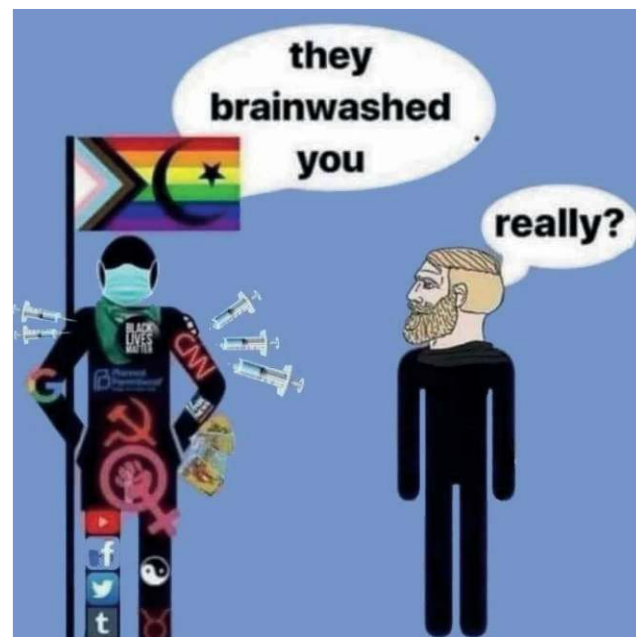
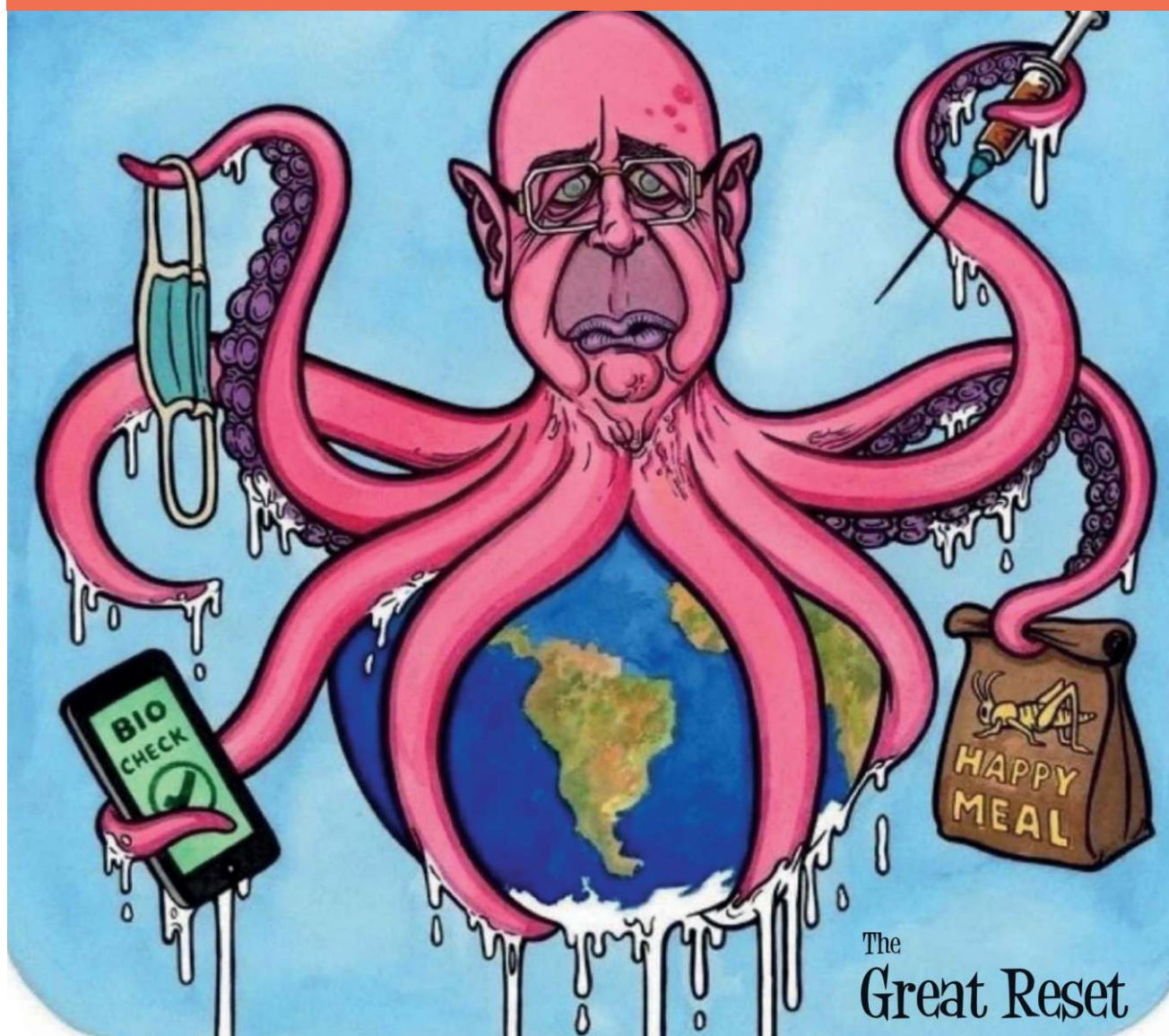

WHO demands end to ALL time limits on abortions: Agency says laws preventing termination at any point risk violating rights of 'women, girls or other pregnant persons'

- Health organisation claims laws preventing abortion at any point violate rights
- One of its 'external experts' claims womb shouldn't be used as its an 'emotional'
- Tory MP described abortion up to birth as 'unacceptable' and 'truly shocking'

The world's most influential health organisation is calling on governments to scrap the legal time limit on abortion, The Mail on Sunday can reveal.

New guidelines issued by the World Health Organisation (WHO) claim laws preventing abortion at any point during pregnancy risk violating the rights of 'women, girls or other pregnant persons'.

But last night Tory MP Fiona Bruce, co-chair of the All-Party Parliamentary Pro-Life Group, described any proposal to legalise abortion up to birth as 'completely unacceptable' and 'truly shocking'.

She added: 'A viable human being could have his or her life ended up to the point of birth. Yet a day, an hour, even moments later, similar action against a child could constitute murder.'

The WHO's 'Abortion Care Guideline' published this month – six years after the MoS revealed the Royal College of Midwives was pushing for the same policy – also recommends that governments:

- Allow abortion under all circumstances – ruling out laws banning terminations because the foetus is the 'wrong' sex;
- Stop women requiring approval from a doctor or nurse to have a termination;
- Roll out 'pills by post' schemes so that women can be sent abortion medication after a phone call;
- Curtail medical professionals' rights to refuse to take part in abortions on conscience grounds.

The United Nations, which oversees the WHO, has welcomed the suggested removal of what it

called 'unnecessary policy barriers to safe abortion', including 'limits on when an abortion can take place'.

But nowhere in the 210-page document is there mention of the ethical debate about the rights of the unborn child, nor if abortions are morally acceptable when after 22-24 weeks the foetus has a good chance of surviving if born prematurely.

It is also silent on sex-selective abortion, despite the termination of female foetuses being common in countries such as India, Pakistan and China.

Prior to publication, the WHO consulted a panel of 12 'external experts' including Dr Dhammika Perera, global medical director of UK-based Marie Stopes International, whose British arm carries out more than 60,000 NHS abortions a year, and Dr Laura Castleman, of Planned Parenthood Michigan, a branch of the largest abortion provider in the United States.

Dr Perera has previously described terms such as late-term abortion and foetal heartbeat as 'anti-choice rhetoric'.

He also objects to the word 'womb' because it 'assigns emotional and symbolic value to an organ'.

Another member of the panel was Karthik Srinivasan from the International Planned Parenthood Federation, which lobbies to expand abortion rights.

Christina Zampas, of the global Center for Reproductive Rights, which uses donations to 'build, enforce, [and] defend' abortion, advised on human rights law.

It says a review of 21 studies found that when women are denied later terminations it 'can be viewed as [being] incompatible with... international human rights law'.

It adds that time limits on abortion might also breach equality laws because they have a 'disproportionate impact' on some groups, such as teenagers and the poor.

In England and Wales women can have abortions for 'social' reasons up to 24 weeks.

After that, they are only legally permitted in circumstances such as the mother's life being at risk or if the child would be born with a severe disability.

The Royal College of Midwives called for the 'decriminalisation' of abortion, including scrapping time limits, in 2016.

The Royal College of Obstetricians and Gynaecologists followed in 2017 and the Royal College of General Practitioners in 2019.

But Ministers have said they have no plans to change the law. The WHO did not respond to a request to comment.

Pro-abortion group Alliance for Choice said abortion should be provided to those 'in need of it as early as possible and as late as necessary.'

Ida Auken was asked by WEF to visualise a future as she sees it in Denmark in the year 2030. The vision became "Welcome to 2030: I own nothing, have no private life and life has never been better". Read the vision on next page.

The WEF makes no secret of the fact that it has an agenda - Agenda 2030 - that it wants implemented in all countries of the world. In short, it is for industry to influence democratic processes much more than in the past, through public and private partnerships (PPPs), and to set the agenda for what we humans need and how we should live. Here are just a few of them: Emmanuel Macron (F), Justin Trudeau (CA), Jacinda Ardern (NZ), Mario Draghi (I), Magdalena Andersson (S), Boris Johnson (GB), Sanna Marin (FIN) and Jonas Gahr Støre (N).

If Ida Auken or Lea Wermelin becomes Denmark's next prime minister, the question can

rightly be asked: What agenda will she govern by and who will she work for? The Danish people or the WEF?

But who is Ida Auken? Let's take a look at her CV.

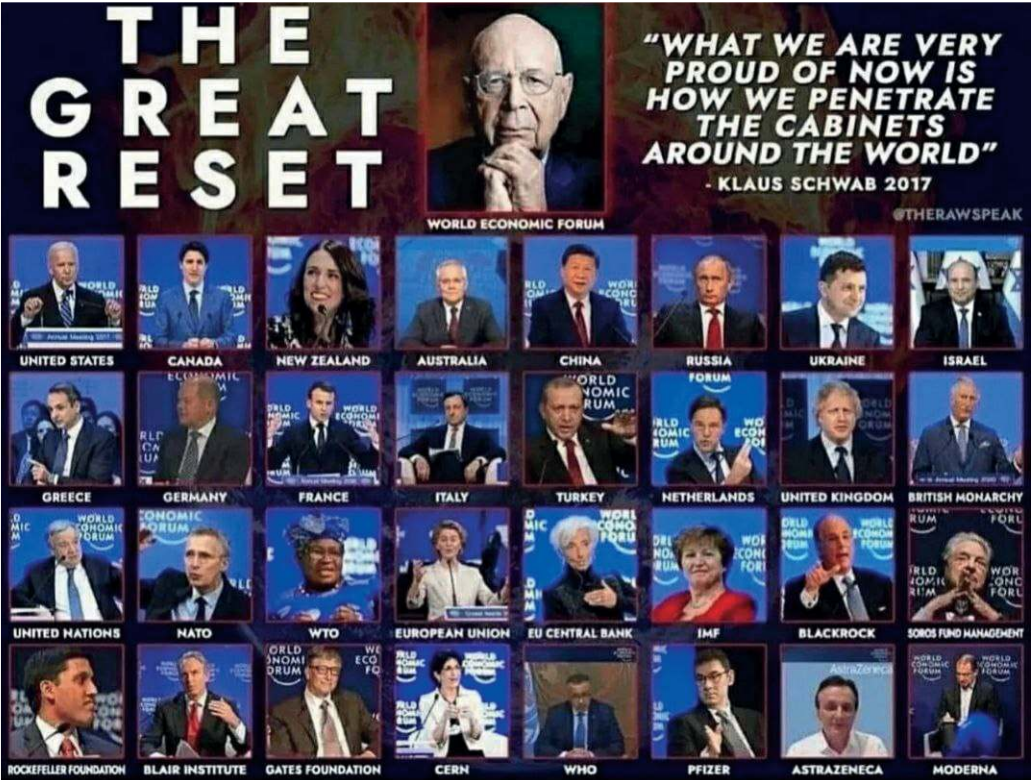
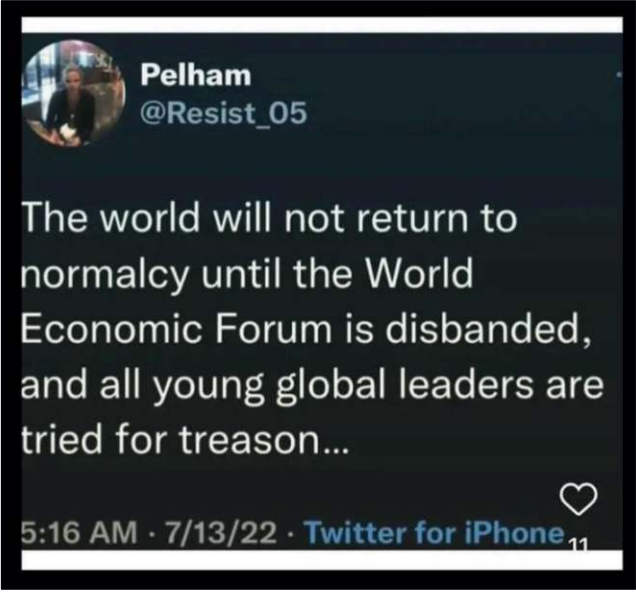

"I Own Nothing, Have No Privacy And Life Has Never Been Better"

"Welcome to the year 2030. Welcome to my city - or should I say, "our city." I don't own anything. I don't own a car. I don't own a house. I don't own any appliances or any clothes.

It might seem odd to you, but it makes perfect sense for us in this city. Everything you considered a product, has now become a service. We have access to transportation, accommodation, food and all the things we need in our daily lives. One by one all these things became free, so it ended up not making sense for us to own much.

First communication became digitized and free to everyone. Then, when clean energy became free, things started to move quickly. Transportation dropped dramatically in price. It made no sense for us to own cars anymore, because we could call a driverless vehicle or a flying car for longer journeys within minutes. We started transporting ourselves in a much more organized and coordinated way when public transport became easier, quicker and more convenient than the car. Now I can hardly believe that we accepted congestion and traffic jams, not to mention the air pollution from combustion engines. What were we thinking?

Sometimes I use my bike when I go to see some of my friends. I enjoy the exercise and the ride. It kind of gets the soul to come along on the journey. Funny how some things seem never seem to lose their excitement: walking, biking, cooking, drawing and growing plants. It makes perfect sense and reminds us of how our culture emerged out of a close relationship with nature.

In our city we don't pay any rent, because someone else is using our free space whenever we do not need it. My living room is used for business meetings when I am not there.

Once in a while, I will choose to cook for myself. It is easy - the necessary kitchen equipment is delivered at my door within minutes. Since transport became free, we stopped having all those things stuffed into our home. Why keep a pasta-maker and a crepe cooker crammed into our cupboards? We can just order them when we need them.

This also made the breakthrough of the circular economy easier. When products are turned into services, no one has an interest in things with a short life span. Everything is designed for durability, repairability and recyclability. The materials are flowing more quickly in our economy and can be transformed to new products pretty easily. Environmental problems seem far away, since we only use clean energy and clean production methods. The air is clean, the water is clean and nobody would dare to touch the protected areas of nature because they constitute such value to our well-being. In the cities we have plenty of green space and plants and trees all over. I still do not understand why in the past we filled all free spots in the city with concrete.

Shopping? I can't really remember what that is. For most of us, it has been turned into choosing things to use. Sometimes I find this fun, and sometimes I just want the algorithm to do it for me. It knows my taste better than I do by now.

When AI and robots took over so much of our work, we suddenly had time to eat well, sleep well and spend time with other people. The concept of rush hour makes no sense anymore, since the work that we do can be done at any time. I don't really know if I would call it work anymore. It is more like thinking-time, creation-time and development-time.

For a while, everything was turned into entertainment and people did not want to bother



themselves with difficult issues. It was only at the last minute that we found out how to use all these new technologies for better purposes than just killing time.

My biggest concern is all the people who do not live in our city. Those we lost on the way. Those who decided that it became too much, all this technology. Those who felt obsolete and useless when robots and AI took over big parts of our jobs. Those who got upset with the political system and turned against it. They live different kind of lives outside of the city. Some have formed little self-supplying communities. Others just stayed in the empty and abandoned houses in small 19th century villages.

Once in a while I get annoyed about the fact that I have no real privacy. Nowhere I can go and not be registered. I know that, somewhere, everything I do, think and dream of is recorded. I just hope that nobody will use it against me.

All in all, it is a good life. Much better than the path we were on, where it became so clear that we could not continue with the same model of growth. We had all these terrible things happening: lifestyle diseases, climate change, the refugee crisis, environmental degradation, completely congested cities, water pollution, air pollution, social unrest and unemployment. We lost way too many people before we realized that we could do things differently."

The United Nations 2030 Agenda decoded:

This week, Michael Snyder published an important article entitled *The 2030 Agenda: This Month The UN Launches A Blueprint For A New World Order With The Help Of The Pope*.

That article references this UN "2030 Agenda" document that pushes a blueprint for so-called "sustainable development" around the world.

Goal 4) Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all

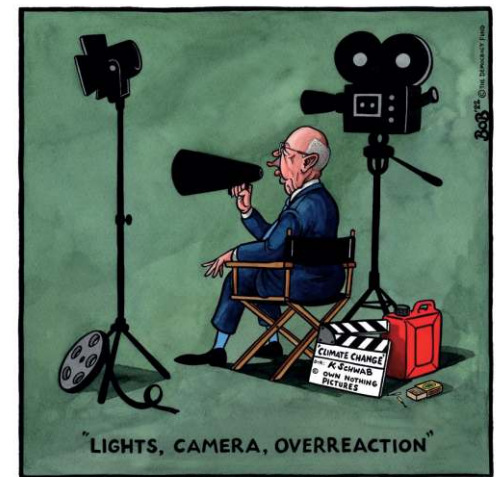

Goal 5) Achieve gender equality and empower all women and girls

Goal 7) Ensure access to affordable, reliable, sustainable and modern energy for all

Translation: Penalize coal, gas and oil while pushing doomed-to-fail "green" energy subsidies to brain-dead startups headed by friends of the White House who all go bankrupt in five years or less. The green startups make for impressive speeches and media coverage, but because these companies are led by corrupt idiots rather than capable entrepreneurs, they always go broke. 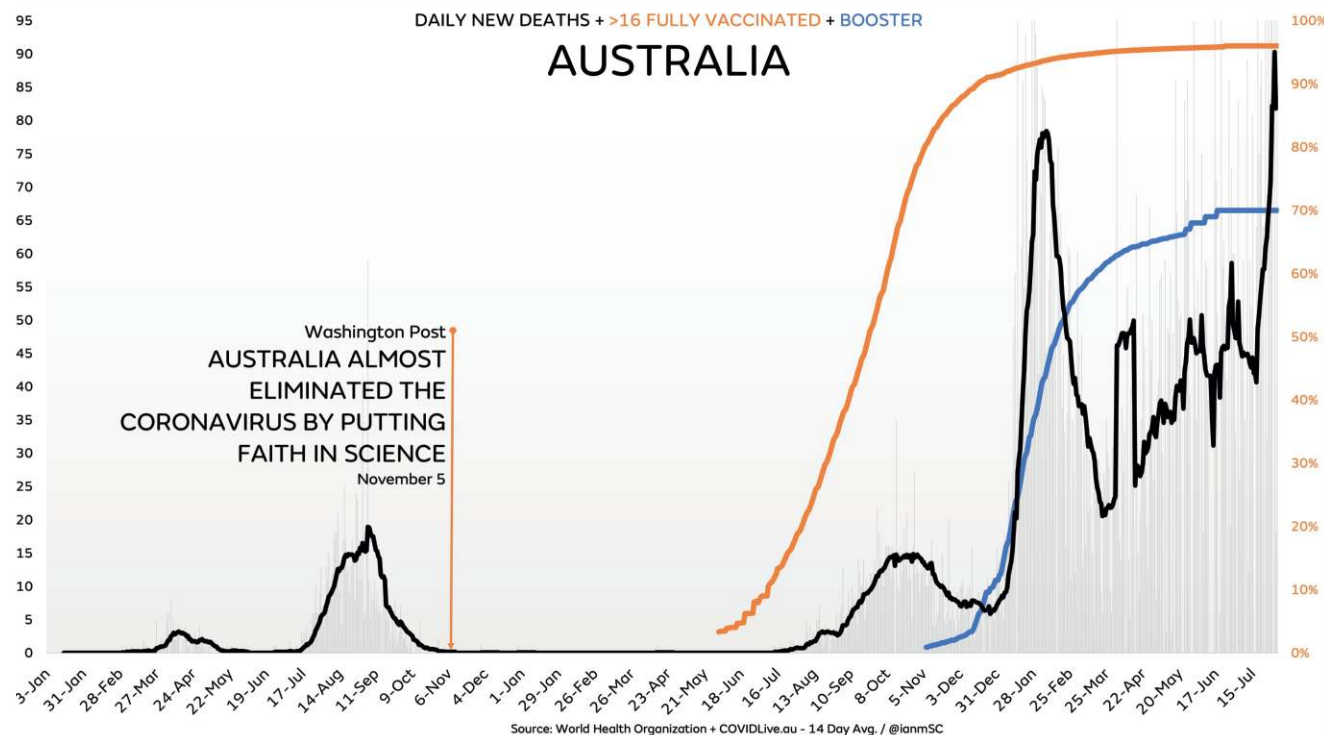
“No one mistreated their citizens more than Australia during the crisis,” added another. “The people that did that should be in jail.”

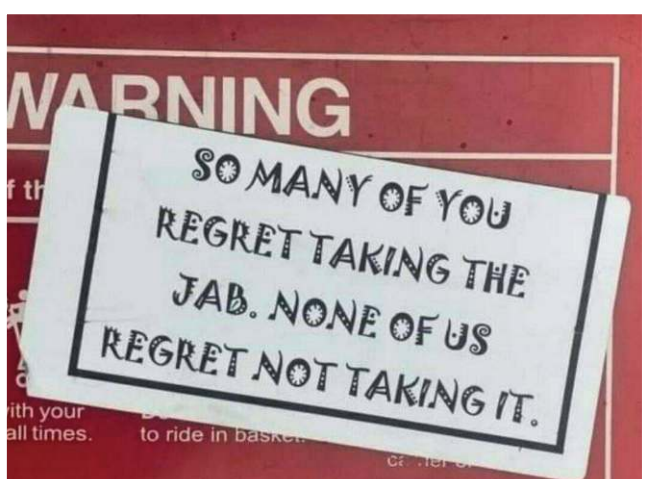


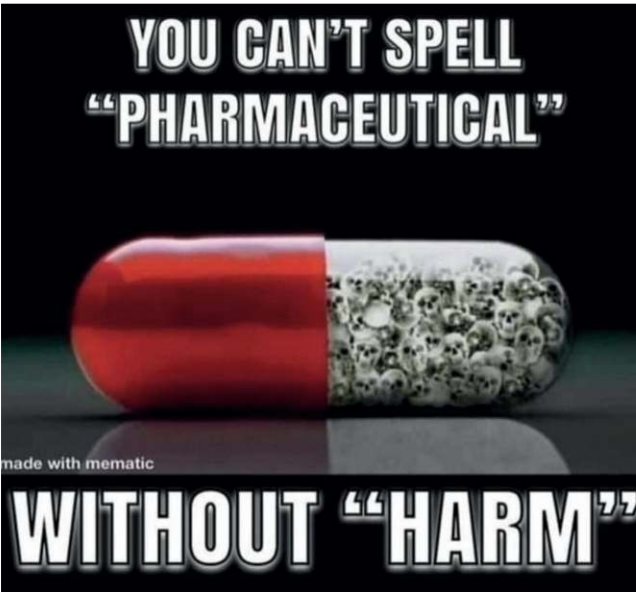

“Trial Site News recently were able to review leaked internal emails from the European Medicines Agency (EMA) and meeting report between the agency and Pfizer. The EMA oversees the evaluation and supervision of medicinal products for the European Union. Like other regulatory health bodies, its main responsibility is to protect and promote public health. Snapshots of internal EMA email correspondence; a November 26, 2020, PowerPoint presentation from a pivotal meeting between Pfizer and the agency, as well as a confidential 43-page Pfizer report were provided by an anonymous source because of their trust in Trial Site’s commitment to transparency, accessibility, and accountability in furtherance of a highly ethical, quality-focused and public health-centric biomedical research industry.

Regulatory agencies, like the EMA, the Food and Drug Administration (FDA) in the U.S. and the UK’s Medicines and Healthcare products Regulatory Agency (MHRA) are chartered to make decisions based to better the public. External influences such as political or media pressure are not meant to be a driving factor in their decision-making, however, when it came to pandemic conditions and the fast-tracked conditional marketing authorization of the Covid-19 vaccines (particularly for the mRNA-based vaccines produced by Pfizer-BioNTech and Moderna), it appears the latter won the day.

The time period of the email correspondence in question stretches from November 10 – 25, 2020, just weeks before the EMA granted CMA (conditional marketing authorization) for the Pfizer-BioNTech Covid-19 vaccine on December 21, 2020. The FDA granted EUA (emergency use authorization) for this vaccine on December 11 with the MHRA making it first to the finish line on December 2. Understandably, the world was gripped by a pandemic at the time, where there was immense impetus to authorize a vaccine to protect people

China approves Genuine Biotech's HIV drug for COVID patients

BEIJING, July 25 (Reuters) - China on Monday gave conditional approval to domestic firm Genuine Biotech's Azvudine pill to treat certain adult patients with COVID-19, adding another oral treatment option against the coronavirus.

The availability of effective COVID vaccines and treatments is crucial in laying the groundwork for China's potential pivoting from its "dynamic COVID zero" policy, which aims to eliminate every outbreak - however small - and relies on mass testing and strict quarantining.

The Azvudine tablet, which China approved in July last year to treat certain HIV-1 virus infections, has been given a conditional green light to treat adult patients with "normal type" COVID, the National Medical Products Administration said in a statement.

"Normal type" COVID is a term China uses to refer to coronavirus infections where there are signs of pneumonia, but the patients haven't reached a severe stage.

China in February allowed the use of Pfizer's oral treatment Paxlovid in adults with mild-to-moderate COVID and high risk of progressing to a severe condition. 96% of NOAA heat measurement stations are corruptly placed to support climate change hoax

It turns out that almost every temperature station operated by the National Oceanic Atmospheric Administration (NOAA) is corruptly placed to make the country appear “warmer” than it actually is, effectively amplifying the “global warming” hoax.

An astounding 96 percent of NOAA’s temperature stations fail to meet the agency’s own “uncorrupted placement” standards, according to research compiled by the Heartland Institute. Most of them are located near objects that trap or produce heat, corrupting their readouts.

Others are located in areas that, since the time of their placement, have become far more urbanized. This, too, is increasing the heat readouts and making it seem all across the board that “climate change” is real. (Related: The biggest heater of the planet is the sun, not cow flatulence or gas-powered vehicles.)

“With a 96 percent warm-bias in U.S. temperature measurements, it is impossible to use any statistical methods to derive an accurate climate trend for the U.S.,” says Heartland Institute Senior Fellow Anthony Watts, the study’s director.

“Data from the stations that have not been corrupted by faulty placement show a rate of warming in the United States reduced by almost half compared to all stations.”

A press release from the Heartland Institute further explains the standards that NOAA is supposed to use to decide whether or not a temperature station is placed correctly for optimal accuracy – standards that the agency is not currently following.

“NOAA’s ‘Requirements and Standards for [National Weather Service] Climate Observations’ instructs that temperature data instruments must be ‘over level terrain (earth or sod) typical of the area around the station and at least 100 feet from any extensive concrete or paved surface,’” the release states.

“And that ‘all attempts will be made to avoid areas where rough terrain or air drainage are proven to result in non-representative temperature data.’”

If NOAA were following its own guidelines, average temperatures across the United States would be far lower than what is being reported. It would also be revealed based on accurate data that the country is not, in fact, warming.

2009 study similarly found that vast majority of NOAA temperature stations are producing inaccurate temperature readouts

The Heartland paper follows an earlier one published back in 2009 that similarly points out the flawed data coming from NOAA temperature stations.

Entitled “Is the U.S. Surface Temperature Record Reliable?” that study looked at more than 1,000 surveyed stations and found that 89 percent of them



have heat-bias issues.

For at least 13 years, in other words, it has been known that NOAA temperature data is inaccurate and unreliable, and yet the climate change narrative has continued on in the name of “science.”

The Heartland Institute’s press release addresses this earlier study, pointing out that the situation with NOAA’s temperature stations has only gotten worse over the years. And there does not appear to be any plans in place to fix the problem.

“The original 2009 surface stations project demonstrated conclusively that the federal government’s surface temperature monitoring system was broken, with the vast majority of stations not meeting NOAA’s own standards for trustworthiness and quality,” the announcement states.

H. Sterling Burnett, director of the Heartland Institute’s Arthur B. Robinson Center on Climate and Environmental Policy, commented that after personally surveying NOAA surface stations back in the spring, he can confirm the 2009 report findings.

“This new study is evidence of two things,” Burnett is quoted as saying.

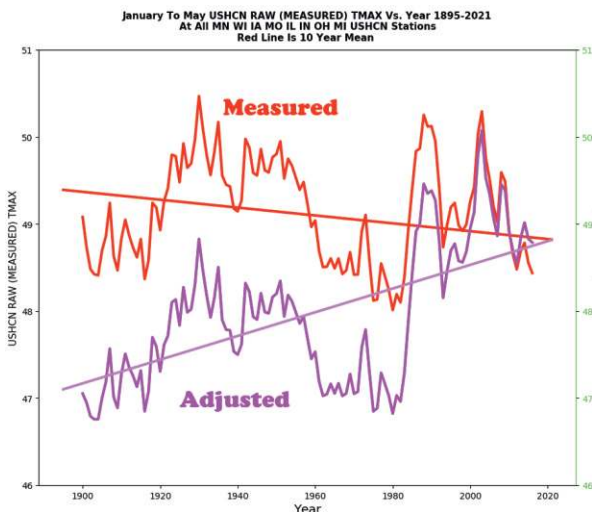
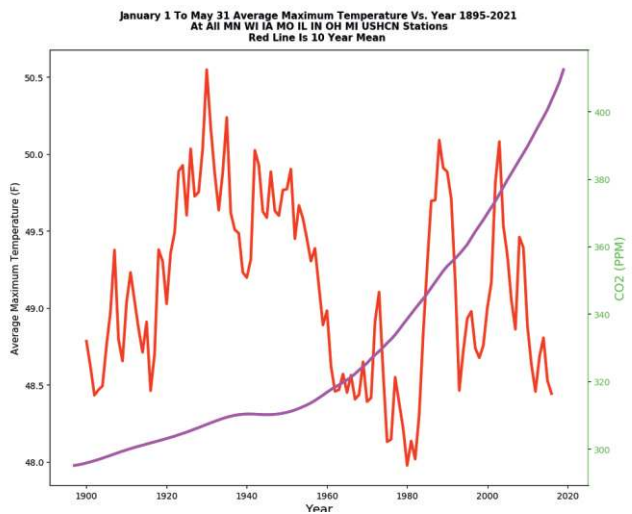

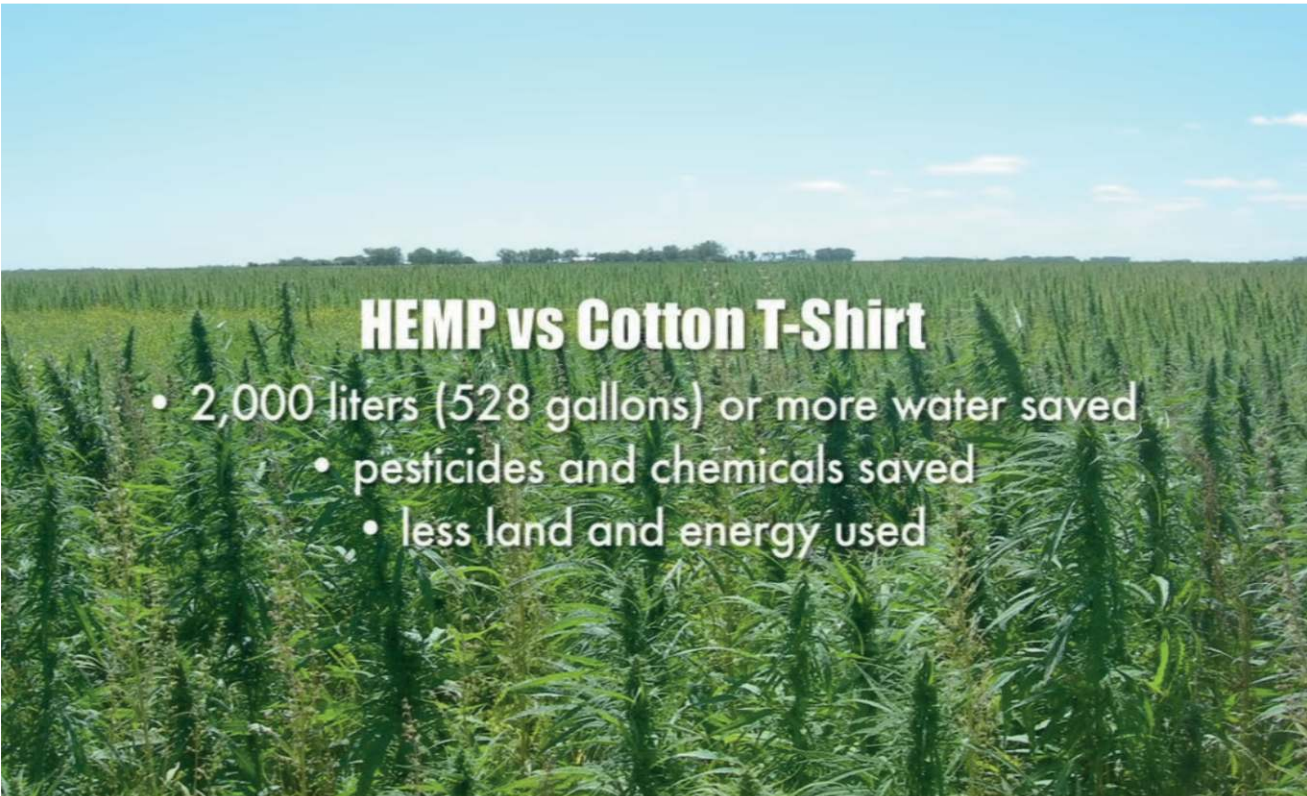

Three Large American Multinationals Bought 17 Million Hectares of Ukrainian Agricultural Land



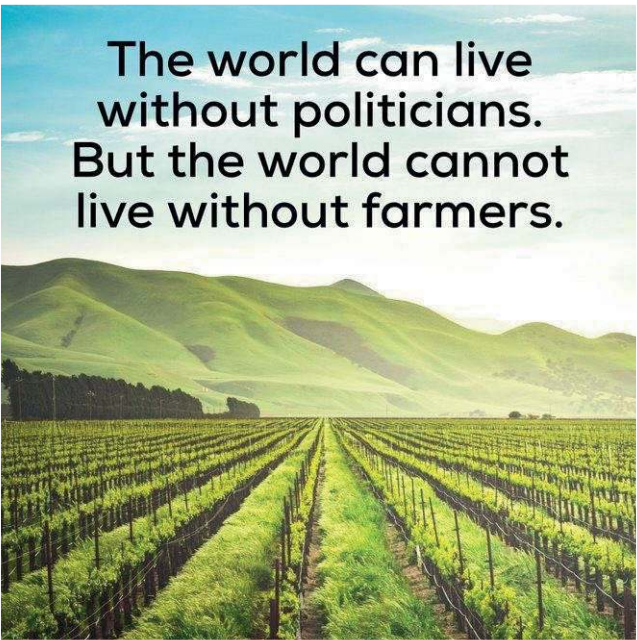

Toxic chemicals in the environment are making children dumber

Every child born in the U.S. is said to be contaminated with industrial chemicals, including endocrine disruptors that affect brain development.

Brain function is often evaluated by intelligence tests, and these IQ scores have been declining since the mid-1990s. This ongoing decline is well documented in Europe, the U.S. and Australia.

While IQ measurements are not perfect, scientific studies have shown that chemical exposure negatively affects brain function among children. This is why many professionals, including numerous medical and scientific organizations, are focusing on the “soup” of chemicals children are being exposed to at an early age.

Dangers of endocrine-disrupting chemicals

Endocrine-disrupting chemicals interfere with hormones. Newborn babies end up being pre-exposed to mixtures of over 200 of these chemicals, which include phthalates, perchlorate, fluoride, bisphenol-A (BPA) and its substitutes, parabens, polychlorinated biphenyls (PCBs) and dichlorodiphenyltrichloroethane (DDT), and even heavy metals like lead and mercury.

These chemicals can be found in the amniotic fluid that surrounds the baby in the womb when the brain is forming at an incredible rate with thousands of nerve cells being born per second.

Contamination does not end there. Children absorb more of these chemicals through the mother’s milk or formula; through the air that the baby breathes; and in products like creams, lotions and baby wipes.

Phthalates are chemicals included in many consumer products, such as those for personal care, processed food, food packaging materials and even medical supplies. Other studies also showed that exposure to these chemicals causes reductions in IQ. (Related: Society’s declining IQ linked to early

chemical exposure in children, new research finds.)

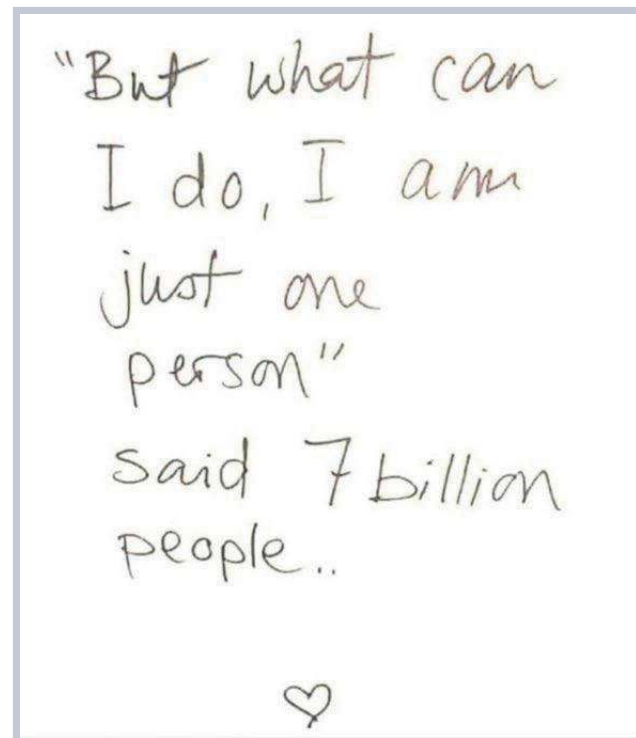
Perchlorate is a thyroid disruptor that is usually found in rocket fuel. However, it also turns up in food packaging and even in groundwater, which can affect food products. It acts by reducing the ability of the body to use iodine, which is essential in the formation of the thyroid hormone. It affects IQ by upsetting thyroid function and producing a state of insufficiency.

Fluoride used to be added to drinking water until one of the most clear-cut demonstrations of the chemical lowering IQ was reported in Canada. A study measured the IQ of Canadian children living in different cities and found that those with fluoride in their drinking water have lower IQ scores.

“Legacy” chemicals like PCBs and DDTs have been banned in production but still remain in the environment. By interfering with the thyroid system, they also decrease IQ in children and adults who have been exposed as children.

Mercury is also known to disrupt brain development. There had been studies that showed at least 2.5 IQ points were lost in a cohort of exposed children in South Korea.

Each of these chemicals is dangerous on its own, but a mixture of them can contaminate children from conception and cause irreversible damage to their brains.

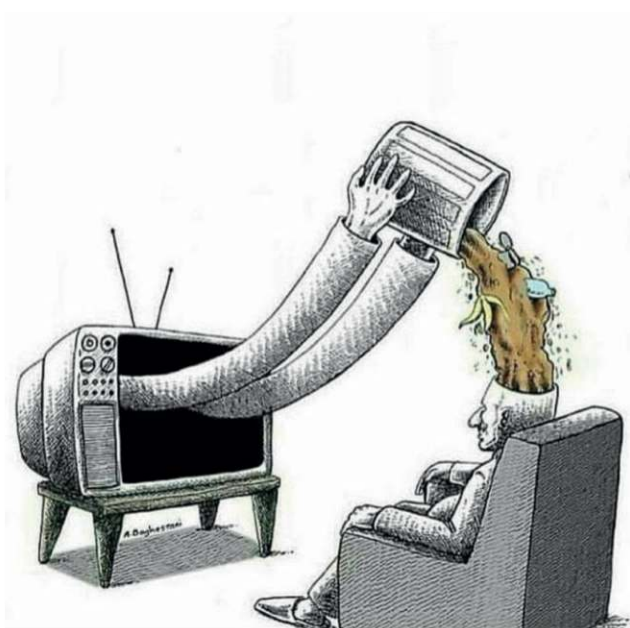

Solution For Current Economic Crisis and Inflation

The current economic crisis with an inflation we have not seen since the second oil crisis in 1979 has emerged due to a huge expansion of the money supply during the last two years corona pandemic. This money were used to finance the lock down of large parts of the public sector and, to a lesser extent pay some compensation to smaller companies, many of which were indirectly forced to close up shop, while the largest companies were allowed to remain open. In addition, these funds were used for a huge purchase of vaccines, masks, tests, and hiring people in the public sector to conduct tests, provide vaccines, and general surveillance and "infection detection" of the population. These many billions initially caused an increase in the house prices, but not in energy and food prices to the same extent, since there was a good balance between supply and demand. However with the war in Ukraine and the subsequent sanctions on cheap energy from Russia, energy prices have risen, simply by politically removing the supply of energy by banning the import of energy from Russia. At the same time, the destruction of many food-producing factories, as well as the lack of the possibility of importing fertilizers from Russia, have caused an expected shortage of food and, accordingly, an increase in prices.

When the money supply increases, it can only lead to two things; increase in growth and/or inflation. Now I have mentioned inflation above, but there have also been growth and earnings opportunities in several parts of the economy, thus the largest companies have announced record profits during the pandemic. The biggest winners have been the manufacturers of vaccines, tests and masks but also oil companies, banks, other large multinationals and the big investment companies such as Black Rock and Vanguard.

A feature and advantage of the multinational corporations is the so called "transfer pricing", which means that they simply do not pay taxes, or practically do not. They can use this loophole to place their profits in tax havens. Part of these savings is then used for lobbying, it is possible this is why no politician has so far proposed measures that would effectively tax the multinational corporations.

There has also been no or surprisingly little popular support for taxing multinationals, and this may be due to the extremely successful meme that so many people automatically respond to if you suggest that multinationals should also pay taxes or simply mention that they do not pay taxes. The meme is: "well, they create many jobs" ... try to do the experiment yourself and ask some people if they do not think it is unjust that people and smaller companies have to pay taxes while the multinational companies do not pay anything.

The fact is that small companies also "create jobs", and they do so despite the fact that they alone among companies bear the tax burden. There is no natural law or written anywhere in the Constitution that multinational companies should be allowed to operate with better conditions than local companies.

We are now in a situation where property prices have risen, rents on apartments have risen, oil, electricity, energy and food prices have risen significantly, and what is worse, much faster than wages, so this winter will be very harsh for many



people and smaller businesses.

Here are some good news.

A solution that will ensure that all people and small as well as large companies can afford to pay for energy and food this winter:

- Introduce a 0.1% tax on all digital transfers of money. Use the proceeds to reduce taxes on energy prices, including electricity, gasoline and heating oil.

In order to operate all companies simply have to charge the amount on every single transfer and deposit the amount into the account of the Ministry of Finance in each country.

I would suggest that you contact your local politician and the party you may be a member of and suggest that they take up this idea.

What's not to like?

Ordinary people and small businesses can easily afford to pay 0.1% each time they transfer money. So can the multinational corporations however the largest companies have to transfer huge amounts of money in order to operate their economic activities.

This will ensure that, for the first time in world history, multinational companies pay taxes. This is only fair that the companies that have benefitted from the pandemic as well as the financial crisis with huge profits give some of it back to the societies they benefit from operating in.
