Here are six ways to ensure a decentralizing of economic power. The political power will be decentralized the same time.

1. Introduce a transfer tax on all digital transfers of money. To begin with 0,1%. The proceed should be earmarked to pay for the rising prices on electricity and heating of people's homes. Ideally increase this taxation until the proceed covers the entire income tax as well as corporation tax, which is mainly paid by local businesses, thus levelling the playing field with the largest multinational corporations. I estimate 1% will be enough to cover all income tax. The goal is to transfer the tax burden from human beings and small businesses to large corporations and consumption.
2. Change VAT to a non tax deductible sales tax including business to business. If we also tax business to business transactions, then we can lower the rate by at least 50%. This new sales tax will thus replace the VAT, that is currently only being paid by the consumer. The new tax will be paid mainly by large corporations, and the rest of us when we consume. Consumers will thus only pay half of what they currently pay in VAT. This will transfer roughly half the tax burden of the VAT from human beings to corporations.
3. Introduce an import tax. This is good for the climate as more goods will be produced locally, while at the same time moving taxation from people to corporations. This tax is only paid by corporations.
4. Lastly take back the power to create money from the privately owned banks. The monetary base should still increase each year but instead of spending it on pharmaceutical products, bailing out the banks, wars of aggression or large investors buying up real estate, we divide the entire money creation on a per capita basis.
5. Interest free loans to human beings and interest bearing loans to businesses. This will ensure a wealth transfer from the largest wealthiest corporations to human beings. This will ensure that most people will own their own home.
6. No property tax on people's main home. Charge property tax on people's second home as well as real estate owned by corporations. This will also move the tax burden from human beings to corporations.
